

## **PRESIDIO INDEPENDENT SCHOOL DISTRICT ORDER CALLING FOR ELECTION**

**BE IT RESOLVED AND ORDERED** by the PRESIDIO INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES that an election shall be held on Saturday, May 3, 2025 for the purpose of filling three full-term, four-year positions on the Board of Trustees.

1. An election will be held to fill the expiring terms of three full-term, four-year positions on the Board of Trustees currently held by the following individuals: Iris Galindo, Juventino Martinez and Jusby Vazquez.
2. The School Board Election will be held Saturday, May 3, 2025 at the Presidio Activity Center (PAC), 1200 E. O'Reilly Street, Presidio, Texas 79845, between the hours of 7:00 a.m. and 7:00 p.m.
3. Applications for a place on the ballot may be filed from January 15, 2025 to February 14, 2025 between the hours of 8:00 a.m. and 5:00 p.m. with the Secretary of the Board, or the designee in the office of the Superintendent of the Presidio Independent School District in the School District's Administration Building, 701 E. Market Street, Presidio, Texas 79845, pursuant to Tex. Education Code §11.055. A completed, sworn application, delivered in person, or by mail, Fax: (432) 229-4228, or email [iruiz@presidio-isd.net](mailto:iruiz@presidio-isd.net) must be received by the 5:00 p.m. deadline on February 14, 2025. NOTE: Each candidate must be a resident of the PRESIDIO INDEPENDENT SCHOOL DISTRICT, must be a qualified voter, and be otherwise qualified to hold the position of Trustee of a public independent school district under Texas law.
4. Write-in candidacies shall also be permitted, pursuant and subject to Texas Education Code § 11.056. Individuals requesting write-in candidacy must complete a declaration no later than 5 p.m. on February 18, 2025, and file it with the Secretary of the Board, or the designee in the office of the Superintendent of the Presidio Independent School District in the School District's Administration Building, 701 E. Market Street, Presidio, Texas 79845. Declarations delivered in person, or by mail, FAX: (432) 229-4228, or email [iruiz@presidio-isd.net](mailto:iruiz@presidio-isd.net), and it must be received by the deadline of 5 p.m. on February 18, 2025.
5. The date for the candidates to draw ballot positions shall be Monday February 24, 2025 at 5:00 p.m in the Presidio ISD Board Room at the School District's Administration Building, 701 E. Market Street, Presidio, Texas 79845. Ballot order

drawing will determine the order in which the respective names shall appear on said ballot in accordance with law and pursuant to Texas Election Code § 52.094. Notice of this drawing shall be posted and mailed in accordance with Texas Election Code § 52.094 (c) and (d). No person shall be permitted to have his or her name appear on said ballot as a candidate until he or she has filed with the Superintendent or Secretary of this Board (or designee) a loyalty affidavit, as required by Section 141.031 of the Texas Election Code. The form of the affidavit required is included with the prescribed form of the Application for a Place on the General Election Ballot, available in the office of the Superintendent of the Presidio Independent School District.

6. Early Voting by personal appearance shall be between the dates of April 22, 2025, and April 29, 2025, between the hours of 8:00 a.m. and 5:00 p.m. at the Presidio Activity Center (PAC), 1200 E. O'Reilly Street, Presidio, Texas 79845 and on Friday April 25, 2025 and Tuesday April 29, 2025 between the hours of 7:00 a.m. and 7:00 p.m. Early voting shall take place on the dates and during the hours required by law.
7. Voting shall be by paper ballots, provided however, touchscreen voting machine will be available to voters as an alternative and to educate voters in the use of this voting system. Ballots conforming to the requirements of the law of the State of Texas shall be prepared with the names, without titles, of all candidates, and ballots shall be provided by the persons appointed to hold said elections and shall be distributed in due time to the judges holding said elections together with the necessary voter registration list showing voters qualified voters within the PRESIDIO INDEPENDENT SCHOOL DISTRICT. All resident, qualified voters within the District shall be entitled to vote in the election.
8. The presiding Election Judge and Election Clerks shall be named at a later date.
9. Applications for ballots by mail may be picked up from 701 E. Market Street, Presidio, Texas 79845, and should be mailed to: Presidio ISD, Attn: Early Voting Clerk, P.O. Box 1401, Presidio, Texas 79845, or may be submitted by email to: [iruiz@presidio-isd.net](mailto:iruiz@presidio-isd.net). The deadline for receipt by the Elections Administrator of an application for an early voting ballot to vote by mail shall be April 22, 2025, as determined by Section 84.007 of the Texas Election Code. Federal postcard application "FPCA" voting shall be conducted pursuant to Chapter 101 of the Texas Election Code, and postmarked applications for a ballot thereunder must be received by April 14, 2025. Late ballot voting shall be conducted pursuant to Chapters 102 and 103 of the Texas Election Code.
10. That this election shall be combined with other elections to be held on the same date. That the President of the Board be and is hereby authorized to execute and Interlocal Agreement for a Joint Election with the City of Presidio, pursuant to, and meeting the

requirements of, Chapter 271 of the Texas Election Code, and Section 11.0581 of the Texas Education Code.


11. Notice of election and copy of this Order shall be posted on the bulletin board used for posting notices of meeting of Board of Trustees, and on the District's Internet website, no later than April 12, 2025, and shall remain posted continuously through election day, pursuant to Tex. Election Code § 4.003. Notice of the Election, Including the location of each polling place and hours the polls will be open, shall also be published not earlier than April 3, and not later than April 23, in a newspaper published within the PRESIDIO INDEPENDENT SCHOOL DISTRICT, pursuant to Tex. Election Code § 4.003. Notice of the election shall be delivered to the County Clerk and to the voter Registrar of Presidio County no later than March 4, 2025, pursuant to Tex. Election Code § 4.008.
  
12. That said, elections shall be held an returns thereof made to the Board of Trustees of the PRESIDIO INDEPENDENT SCHOOL DISTRICT in accordance with the general election laws, and that said Board of Trustees shall canvass such returns, declare the results of such elections, and issue certificate of such elections to the three candidates shown by such returns to have received the highest number of votes.
