- 1. Call meeting to order: Mayor Ferguson called the Regular City Council meeting for June 3, 2025 at the Presidio Activity Center into order at 6:05 p.m.
- 2. Quorum Check: City Secretary checked for quorum. The regular meeting quorum was established according to Texas Open Meetings Act.

DISCUSSION: Mayor Ferguson stated before discussing the public's needs, he gave some background on the funding opportunities through the Texas Community Development Block Grants Program. Our community has received from TxCDBG funding in the past that include Water/Drainage Improvements, Rural Economic Development Planning, Water Storage Tank, Water Meters, and Generators at the Well and Wastewater plant. Mayor Ferguson opened the public hearing for public participation.

The first topic is affordable housing in our community. Mr. Rodriguez stated that the city does not provide any affordable housing for the city.

Second topic Social Services. Mr. Rodriguez stated that the city offers the Senior Center services and the Community Health Program.

Third topic Public Infrastructure. Mayor Ferguson stated that the public infrastructures such as water, and wastewater that have been provided to the city residents since the 1980s. There are some areas still in need of the wastewater system. Mr. Obed Escontrias discussed in providing water along US Hwy 67 along the city's North ETJ. Mrs. Irma Juarez suggested having public and green spaces for the enhancing of tourism for the city examples as an amphitheater, parks, and open gathering space. Mrs. Arian Velazquez-Ornelas suggested providing the needed water and wastewater to the annexed portions of the city. Final topic is Economic Development for the City of Presidio. Mayor Ferguson informed the public that the City of Presidio has been working on the Rural Economic Development Plan through TDA Funding in cooperation with the Presidio Municipal Development District. The one million dollar grant is for economic development and the plan

chosen was for Downtown Revitalization. Ms. Yosdy Valdivia would like to have murals and business buildings painted to beautify Presidio and make it more colorful. Mr. Obed Escontrias asked about street infrastructure for the city. Now that we have outlined many of the needs that we have in our community, let us discuss the specific funding opportunity available. In 2025, TDA is accepting applications for the Community Development Fund and the City submitted an application, committing local matching funds in order to improve our application's score. The City has been invited to continue and submit project details for an application of \$750,000 in grant funding as well as local matching in-kind funds of \$37,500 committed in order to improve our application's score. The projects in the application must benefit primarily low- to moderate income areas. We do not anticipate that any project we identify will result in displacement of residents or businesses; however, if this does occur, we will minimize the impact of such displacement and assist displaced persons as required by the program.

Mayor Ferguson closed public hearing for the City of Presidio Community Development Block Grant Program at 7:08 pm.
