Resolution supporting HAZMAT certification of the border crossings of Presidio, Texas and Ojinaga, Chihuahua

WHEREAS, local, state, and federal authorities in the United States and Mexico have been actively involved in the improvement and expansion of the Presidio-Ojinaga International Vehicular Bridge and the Presidio-Ojinaga International Railroad Bridge to facilitate the flow persons and goods between our nations; and

WHEREAS, in order for certain types of activities to take place at our border crossings, it is necessary to have the required documentation, human resources, equipment and physical infrastructure in place; and

WHEREAS, the transit of hazardous materials, “HazMat,” specifically combustible fuels, across both vehicular and railroad crossings is a commercial activity being advocated by the business sector in Presidio and Ojinaga; and

WHEREAS, the international transit of combustible fuels will be a commercial activity in Presidio; and

WHEREAS, in order for any hazardous materials to transit the international vehicular and railroad bridges at Presidio and Ojinaga, a “Concurrent Letter” must be in place by both the United States and Mexico to make said border crossings HazMat Certified; and

WHEREAS, the transit of hazardous materials across the border at Presidio and Ojinaga would be accompanied by the required emergency response personnel and equipment to manage and contain any emergency situation that might occur by transporting said materials.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESIDIO, STATE OF TEXAS AS FOLLOWS:

The City of Presidio supports the full, binational HazMat Certification of both border crossings in our community.

The City of Presidio recognizes the importance of economic development that can occur through the expansion of the types of international commerce that are designated at our international bridges.

The City of Presidio, Presidio Volunteer Fire Department and Presidio Emergency Medical Service will have all required trained personnel and equipment in place to respond to any emergency that may arise from the transit of designated hazardous materials through our community and on our international bridges.

Resolution supporting the removal of Section 112104 from H.R. 1- One Big Beautiful Bill Act

WHEREAS, Mexican immigrants work legally in Presidio, Texas and many other communities across the United States; and

WHEREAS, Mexican immigrants spend 80% of their income in the United States, sending 20% of their wages to Mexico in what are known as “remittances”; and

WHEREAS, Section 112104 of H.R. 1- One Big Beautiful Bill Act establishes a 3.5% excise tax on remittances by non-citizens to Mexico; and

WHEREAS, Section 112104 violates the 1994 Mexico-U.S. Agreement: Agreement on Recognition Certificates, facilitating cross-border transfers, including remittances; and

WHEREAS, it is the opinion of the Mexican federal government that Section 112104 is discriminatory, adding an additional burden on taxpayers who contribute to the overall financial health of both nations.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESIDIO, STATE OF TEXAS AS FOLLOWS:

The City of Presidio supports all who work legally in our community and have the need to support family or others in Mexico financially.

The City of Presidio urges the United States Congress to remove Section 112104 from H.R. 1-One Big Beautiful Bill Act, thereby eliminating the 3.5% excise tax on remittances to Mexico by non-citizens.
