1. **Call meeting to order:** Mayor Pro-Tem Montoya called the Special-Called City Council meeting for June 23, 2025 at the Presidio Activity Center into order at 6:00 p.m.
2. **Quorum Check:** City Secretary checked for quorum to proceed with special-called meeting.

4. **Recognize and Welcome Visitors – 5 minutes**

Public Comment is reserved for members of the public who would like to address the City Council regarding agenda and non-agenda items. In some situations, City Staff may be able to respond to the public comments with a factual statement or clarification. The City Council may have the item placed on a future agenda for action or refer the item to Management and Staff for study or conclusion.

Mayor Pro-Tem Montoya welcomed public and City of Presidio staff to the special-called meeting on June 23, 2025 at the Presidio Activity Center and opened floor for any visitor to address the City Council for five minutes. Mr. Antonio Manriquez commented on Certificate of Obligation and they are usually used for emergency purchases. Mr. Manriquez is also asking what exactly are the items that the monies to be spent on.

5. **New Business**

- a. **Discussion / action concerning the Presidio County \$5.5 million Certificate of Obligation.**

DISCUSSION: Councilman Juarez asked if anyone had questions and that the election petition was going to happen. Presidio County Attorney, Blaire Parks explained the legalities of the bond. Mrs. Parks stated that there were already under contract to have the County Courthouse elevator fixed. The bond will be used for the Presidio Annex Building remodeling, equipment for County Road & Bridge, County Courthouse, and TxDOT grant matching fund. Mrs. Parks stated that regardless if the bonds are not approved the county would use their reserve funds to complete the items on the bond list. Other discussions from the public were heard.

ACTION: No action.

- b. **Discussion / action on the TxCDBG Grant CDV25-0138 to score and select proposal for Engineering Services.**

DISCUSSION: City Council members scored three engineering firms for the TxCDBG Grant CDV25-0138. Submitted proposals were FXSA Consulting Civil Engineers & Surveyors, Jacob – Martin Professional Engineering and Architectural Services, and Wilson & Company. City Administrator Rodriguez calculated scoring sheets as follows: FXSA scored 317, Jacob – Martin scored 341, and Wilson & Company 388 points. City Administrator stated that the highest score was Wilson & Company with 388 points.

ACTION: Councilman Juarez moved to select Wilson & Company with the highest score of 388 points for TxCDBG Grant CDV25-0138 Grant Engineering Services. Jacob / Martin scored 341 and FXSA scored 317. Councilwoman Martinez-Bailon seconded the motion.

- c. **Discussion / action on the TxCDBG Grant CDV25-0138 to approve the contract for the selected Engineering Services.**

DISCUSSION: Mayor Pro-Tem Montoya asked for a motion.
