- Discussion / action to approve Rio Bravo Songs 2026 expense for \$6,000 as recommended by the Presidio Convention and Visitors Bureau.**

**DISCUSSION:** Mayor Ferguson stated that this was recommended by the Presidio Convention and Visitor's Bureau and would follow all the requirements set by the state. Councilman Montoya asked about the issue with having no hotel room availability in Presidio. Elvira Hermosillo, Convention and Visitor's Bureau member stated that this event has been previously sponsored since 2022 and Ms. Lauren Cecil has been managing the event. Ms. Cecil has made sure to have block room reservations at the hotel for the event. Ms. Cecil has been providing a Google form to the people staying at the hotel for the event to fill out with questions pertaining to where they ate, stayed, and shopped at during the event and give a census of the event.

**DISCUSSION:** Ms. Elvira Hermosillo informed the City Council that this was a ten event music series. Mrs. Nelly Alvarado stated that they will initiate this music series with ten events to see how many Heads in Beds this series will actually bring into Presidio. Ms. Adele Jancovici stated that these events will be different events and they will be more of art exhibitions along with live music. These events will consist of various concerts to be conducted in the span of ten events Ms. Hermosillo stated that the Convention Visitor's Bureau has implemented a form to have the information from visitor's to inquire about their stay and assistance to the local events in order to obtain the required Heads in Beds statistics. The City Council members are supportive of these events in order to get more tourism into the city.
